## Special Terms and Conditions

### GENERAL PROVISIONS

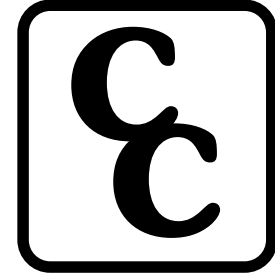
1. PERFECT TEMPERATURE CONTROL WILL ENDEAVOR TO RENDER PROMPT AND EFFICIENT SERVICE HEREUNDER, BUT IT IS EXPRESSLY AGREED THAT PERFECT TEMPERATURE CONTROL SHALL IN NO EVENT BE HELD LIABLE FOR ANY DAMAGE CAUSED BY OR ANY LOSS ARISING OUT OF THE PERFORMANCE OF THIS AGREEMENT.
2. PERFECT TEMPERATURE CONTROL RESERVES THE RIGHT TO REJECT ANY AGREEMENT IF, ON INSPECTION BY A SERVICE TECHNICIAN, EQUIPMENT IS FOUND IN SUCH CONDITION THAT SERVICE WILL BE UNSATISFACTORY TO BOTH PARTIES.
3. IF THE FURNACE HEAT EXCHANGER OR COMPRESSOR FAILS WITHIN THE MANUFACTURER'S WARRANTY PERIOD, THE MANUFACTURER SHALL PROVIDE THE REPLACEMENT HEAT EXCHANGER OR COMPRESSOR. REPLACEMENT OF PARTS NOT INCLUDED IN THIS CONTRACT WILL BE PERFORMED AT A NORMAL HOURLY SERVICE RATE..
4. IT IS MUTUALLY AGREE THAT THIS AGREEMENT COVERS ONLY ELECTRICALLY OPERATED CONTROLS INSIDE THE EQUIPMENT AND DOES NOT COVER ANY ELECTRICAL, PLUMBING OR BALANCING BEYOND THE UNITS. THE AGREEMENT DOES NOT COVER ANY WORK REQUIRED BECAUSE OF NEGLIGENCE, MISUSE OF THE EQUIPMENT, OR BECAUSE OF FIRE, FLOOD, ACTS OF GOD, ELECTRICAL SHORTAGES, WATER, OR DAMAGES CAUSED BY FREEZING.
5. THIS AGREEMENT DOES NOT COVER ANY WORK OR CHANGES WHICH AS SOME FUTURE DATE MAY BE REQUIRED BY GOVERNMENT REGULATIONS, CODES, OR INSURANCE REGULATIONS.
6. NO SERVICE WILL BE RENDERED UNDER THIS AGREEMENT IF THE CUSTOMER HAS A PAST DUE ACCOUNT.
7. PERFECT TEMPERATURE RESERVES THE RIGHT TO CANCEL ANY AGREEMENT WITHOUT NOTICE AND REFUND THE UNUSED PORTION.
8. PERFECT TEMPERATURE LEGAL LIABILITY WILL NOT EXCEED THE SELL PRICE OF THIS CONTRACT.

### BENEFITS & EXCLUSION

- **PEACE OF MIND**—periodic maintenance, keeps your system running at peak, trouble free efficiency. We take the responsibility of scheduling your service calls.
- **EXPERTS AT YOUR SERVICE**—trained service technicians look after your equipment.
- **PREFERRED TREATMENT**—periodic maintenance increases reliability, but if you should need emergency service you have top priority.
- **PRICE PROTECTION**—your preventative maintenance agreement price will not be increased during the current period. Subsequent renewal prices will not be changed without prior notification.
- **AUTOMATIC RENEWAL**—your preventative maintenance agreement will automatically be renewed each year unless canceled by either party.
- **TRANSFERABLE**—this agreement is transferable upon sale of the residence with written notification.
- **EXCLUSION**—filters, thermostats, compressors, heat exchangers, variable speed motors, blower wheels, wiring and “false alarms.”

Service calls initiated by: A/C refrigerant leaks, water leaks, circumstances beyond our control or Acts of God, fuel or EPA changes.
